### AFFIDAVIT TO TAKE A DEFENSIVE DRIVING COURSE

I, the above named defendant, on this day after being duly sworn on oath depose and say, in compliance with Chapter 543, Subchapter B, of the Texas Vehicle and Traffic Laws Transportation Code, that:

1. I have a valid non-commercial Texas driver's license or permit.  
(Indicate below if active military, spouse, or dependent child of active member with non-Texas D.L.)
2. My driving record as maintained by the Texas Department of Public Safety or any other state does not indicate I have successfully completed a Defensive Driving Course or Motorcycle Operator Training course under this section in the past 12 months,
3. I am not taking a Defensive Driving Course or Motorcycle Operator Training course under this section, in Texas or in another state and have not completed a Defensive Driving Course that is not yet reflected on my driving record.
4. The offense charged is for an offense covered by this section (other than speeding at a speed of 95 miles per hour or more; or 25 miles per hour or more over the posted speed limit).
5. I have, and will present to the Court, proof of current financial responsibility (i.e., liability insurance) in at least the minimum amounts required by law, listing me as a covered driver.
