4. THE OFFENSE CHARGED IS FOR AN OFFENSE COVERED BY THIS SECTION OTHER THAN SPEEDING 25 MILES AN HOUR OR MORE OVER THE POSTED SPEED LIMIT AT THE PLACE WHERE THE ALLEGED OFFENSE OCCURRED,
5. I DO NOT HAVE A COMMERCIAL DRIVER'S LICENSE, AND
6. I HAVE PROVIDED CURRENT PROOF OF FINANCIAL RESPONSIBILITY TO THE COURT AS REQUIRED BY SECTION B1, TEXAS MOTOR VEHICLE SAFETY RESPONSIBILITY ACT (CHAPTER 601, TRANSPORTATION CODE).
