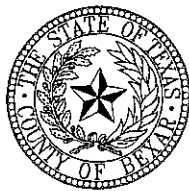

### 3. New Business

#### A. Early Ballot Board

Sec 87.002 states that the Election Board appoints the presiding judge. The same number of clerks must be appointed from each list.

- (c) Precinct officers serving as early board members under Section 87.004 may not be compensated for both positions.

Early ballot board in counties with a population of 100,000 or more may meet to qualify and accept beginning on the 20<sup>th</sup> day before – Oct 19. Due to the large number of emailed ballots per MOVE Act and the new requirements of SB 1, we strongly recommend this for those ballots.

Central Count in counties with a population of 100,000 or more may start counting after the end of the early voting period. We strongly recommend this.
