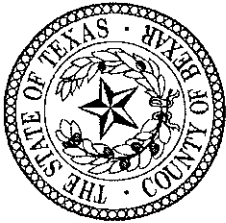

The transfer of \$8,061,613 from the General Fund to the Internal Service Funds was to offset an estimated shortfall at FY2016 year-end. The transfer of \$89,675,237 within the Capital Projects Fund consists of \$300,797 to create funding for the Fleet Acquisition Fund, \$57,000,000 for the County's 10-year regional flood control program and \$32,374,440 from the TXDOT ATD Fund to the Capital Projects Fund to help finance the purchase of the Toyota Field, Alameda Theatre, Family Service Center Association - Facility Acquisition, Joint Basc San Antonio Mission Preparedness Initiatives, and Commemorative Tricentennial Artwork. The transfer of \$2,231,606 from the General Fund to the Capital Projects Fund is for the FY2015-16 replacements of County-owned vehicles. The transfer of \$1,324,765 from the General Fund to the Debt Service fund is to pay debt service on bonds issued to pay for roads. The remaining transfers are the result of normal transactions between funds.
