**Bexar County Medical Examiner Provides First
List of Fatalities From Quintana Road Incident**

The Bexar County Medical Examiner's Office (BCMEO) continued their cooperation with the different consulates to identify all the victims who perished in the truck-trailer found on Quintana Road in San Antonio, TX, on June 27, 2022.

Now that a number of the deceased have been conclusively identified and next of kin notifications have taken place, a first list of victim names can be released. You will find the list attached to this release as a separate page.

As of last night, 47 of the victims have been conclusively identified. Their ages range from 13 to 55. Of these 47 victims, 22 were citizens of Mexico, 19 were citizens of Guatemala, and six were citizens of Honduras.

BCMEO staff continues to work on confirming the remaining six potential identifications.

We will publish additional information based on the conclusively identified cases in due course. Until the decedent's next of kin have been notified, we refrain from releasing more detailed data out of respect for the grieving.
