**AFFIDAVIT TO TAKE A DRIVING SAFETY COURSE**

- 1. I have a valid Texas Driver's License or Permit

- 2. My driving record as maintained by the Texas Department of Public Safety does not indicate that I have successfully completed an approved Driving Safety Course or Motorcycle Operator Training Course, as applicable under this section within the 12 months preceding the date of this offense.
- 3. I am not taking an approved Driving Safety Course or Motorcycle Operator Training Course, as applicable, under this section and have not completed a course under this section that is not yet reflected on my driving record within the 12 months preceding the date of this offense.
- 4. The offense charged is for an offense covered by this section other than speeding at a speed of 95 miles per hour or more, OR speeding 25 miles an hour or more over the posted speed limit at the place where the alleged offense occurred.
- 5. I do not have a commercial driver's license, and
- 6. I have provided current proof of financial responsibility to the court as required by Texas Motor Vehicle Safety Responsibility Act (CHAPTER 601, TRANSPORTATION CODE).
