Dr. Baird gave a talk at the Somerset Historical Society. The president is Linda Ramos. There he met Jessie Alvarado who is a Navarro descendant and Patricia Limon who is a genealogist.

Dr. Ringenbach added that he was at a talk given by Everett Fly. He noted that the Hockley Cemetery is having a cleanup on October 13<sup>th</sup> starting at 8:30 am. Dr. Galan is attending this event.

McKenzie added that UTSA's CAR has been asked to create a synthesis report on the items collected at the Hockley cemetery. Perhaps this can be a template that can be used for future projects.

### **Archives Committee Report:**

The Catholic Archives at San Antonio has a grand re-opening the week of September 17, 2018. The afternoon of the 17<sup>th</sup> was the opening for viewing of the remodeled and expanded archives area at the Catholic Chancery for the workers in the chancery building. On Tuesday the 18<sup>th</sup> in the evening from 6:00 8:30 pm the archives were open to the priests, deacons, officials, and their wives. About 200 attended. There was a blessing of the archives by the archbishop, several

talks and then guided tours. The new vault is finished but nothing has been moved back from storage. The new furniture is still to be delivered to the other rooms. There were a few books on the shelves in the research room for atmosphere. The famous Alamo book was on display for several days. It is now back on display at the Witte Museum. The book was opened to the page where the foundation of Mission San Antonio de Valero was certified, May 1, 1718. On the 19<sup>th</sup> there was a gathering in the evening for historians, archivists, and researchers. There was a light reception and then a talk with a discussion followed by tours of the facility. On the 20<sup>th</sup> there was to be a dinner for the major donors followed by tours of the facility. The opening was covered by the *Express News* and also *Today's Catholic* newspapers.

The archivist emeritus has found a new position at the National Archives of the Marianist Province of the United States (NAMBUS). His title is that of researcher. He has put order in some of the 8 boxes of Miscellaneous that were shipped down recently from St. Louis and is now listening to hundreds of hours of cassette tapes to determine which are to be digitized and which had to be destroyed. There is one set of 24 tapes, 90 minutes each on the history of the religious order in the US 1850-1994, which will be saved. I found it fascinating. I also attended a lecture by Dr. Poyo on the History of San Antonio through Art. The next night I was with him and the staff of NAMBUS, to help an art history class preparing students to be museum curators. Dr. Poyo told the history of the Brothers in San Antonio 1852-1927 and how we fulfilled the bishop's order when we came to teach the Hispanic boys. Dr. Poyo has studied the student roles to see the ratio of Hispanics to Anglos up to the time of the university. Now St. Mary's University is 75% Hispanic.

The San Antonio Regional Archivists will hold its fall meeting on Friday, October 5<sup>th</sup> at the Catholic Chancery at 3:00. The next report will detail this meeting.

This book was found in the vault and put on display at the Archives reopening.

Draves said it must have been William Louis Menger who received the book as a gift.

This is a public symposium on Friday the 26<sup>th</sup> at 3:20 in the afternoon. We are in the program as the sponsor, and McKenzie is the moderator for that session. Great research will be presented on that panel by Dr. Casey Hanson and CAR. There will be work from Military Plaza presented as well as other research. McKenzie encourages everyone to attend.

Ringebach- Bexar Heritage – Juliette Moke has been promoted to be the Manager to the Bexar Heritage Center. She will be looking for a part-time position for a college student, and she is looking for history students who have strong recommendations from professors. Carlson- the 39<sup>th</sup> Hispanic Genealogy Conference; Carlson and Galan attended and presented. George Farias is looking for support for a massive collection that could be used for genealogy. He is looking for a home for this collection.

Almáraz introduced the guest-Colonel Alan Ernst- He is doing good work in history and is interested in becoming a part of the commission.
