

**ORDER APPROVING NORTHWEST VISTACOLLEGE AND
PALO ALTO COLLEGE AS EARLY VOTING AND ELECTION DAY
VOTING SITES FOR TRUSTEE GENERAL ELECTION ON MAY 7, 2022
AND APPROVING OTHER COLLEGES AS EARLY VOTING AND
ELECTION DAY VOTING SITES IF ADDED BY BEXAR COUNTY
ELECTIONS ADMINISTRATION**

WHEREAS, the Board of Trustees (the “Board”) of the Alamo College Community District (“ACCD” or the “College District”) has called a General Election for trustees to serve six-year terms for single-member Districts One (1), Two (2), and Three (3) on the Uniform election day of Saturday, May 7, 2022; and

WHEREAS, pursuant to Chapter 271 Texas Election Code and Chapter 791 of the Texas Government Code, the Board has ordered that the General Election be conducted by Bexar County, Texas Elections Administration under a contract for election services and be conducted jointly with other political subdivisions as determined by Bexar County Elections Administration; and

WHEREAS, the Board is required to approve the early voting sites for the Trustee General Election and any Runoff Election; and

WHEREAS, Bexar County Elections Administration has designated Northwest Vista College and Palo Alto College as early voting and election day voting sites for the Trustee General Election; and

WHEREAS, the Board desires to request Bexar County Elections Administration to add the Alamo Colleges listed below to serve as early voting and/or election day voting sites for the Trustee General Election and any Trustee Runoff Election.

IT IS, THEREFORE, ORDERED BY THE BOARD OF TRUSTEES OF THE ALAMO COMMUNITY COLLEGE DISTRICT THAT:


Section 1. Approval of NVC and PAC. The Board hereby approves the designation of Northwest Vista College and Palo Alto College as Early Voting and Election Day Voting Sites, as requested by Bexar County Elections Administration, for the General Election of Trustees for Single-Member Districts One (1), Two (2), and Three (3) on the uniform election day of Saturday, May 7, 2022.

Section 2. Request to Add Colleges. The Board hereby directs that Bexar County Elections Administration be requested to add the colleges listed below as additional Early Voting and/or Election Day voting sites for the Trustee General Election on May 7, 2022 and any Runoff Trustee Election on or about June 8, 2022, as approved at the Regular Meeting on January 25, 2022 and at District expense, if so required by Bexar County Elections Administration.


