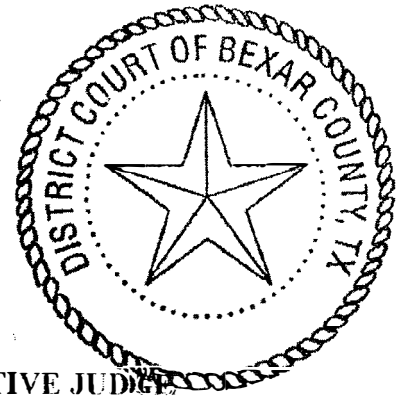

**ORDER OF THE BEXAR COUNTY LOCAL ADMINISTRATIVE JUDGE
SUSPENDING JURY SERVICE UNTIL MARCH 14, 2022**

While the Covid-19 positivity rate is currently falling in Bexar County from unprecedented highs, the rate remains far above the level considered appropriate for resuming public gatherings such as jury trials. The local health authority advises that the number of Bexar County Covid-19 infections is likely to remain above the desired level on March 1, 2022. After careful deliberation and consultation with the local health authority, and in an abundance of caution, the Court has determined the best course of action is to continue the current suspension of jury service through March 11, 2022. It is anticipated that in-person jury trials will resume on March 14, 2022.

Therefore, by authority of the Texas Supreme Court's 45th Emergency Order and as described in Attorney General Opinion KP-0322, it is HEREBY ORDERED that in person jury service in Bexar County will continue to be suspended through March 11, 2022.

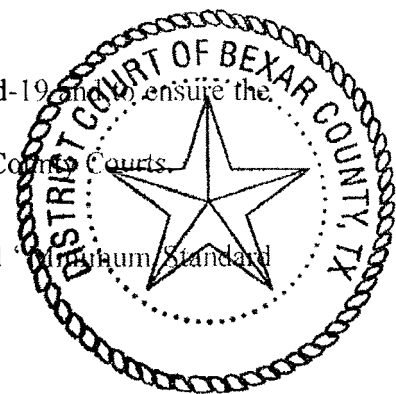
Per the Protocols and based on the continuing Severe Risk Level of the City, all persons entering for court business the Bexar County Courthouse, the Cadena Reeves Justice Center, the Paul Elizondo Tower, the Tejeda Juvenile Justice Center, the 600 Mission Rd. Building (386th District Court), all Justice of the Peace buildings, and any building housing any specialty courts are required to wear face coverings. Further, it is strongly encouraged that all courts consider moving, as much as possible, to remote proceedings.

Special Order No. 72711, issued December 17, 2021 and entitled "Minimum Standard Health Protocols For Bexar County Court Proceedings", remains in effect.
